- 1. See something, say something and intervene if necessary or report if not possible to intervene.

- 3. Database of police officers who have been disciplined accessible by general public and other police bureau
- 4. Use of force such as choke holds are now considered use of deadly force and not a restraint
- 5. Definition of a Riot and appropriate use of tear gas.

  - Q How can we support you?

  - A I would like those that are causing trouble to be held accountable for any actions, that includes the police.
  - Q What are your thoughts on defunding the police and how to ensure the funds get to the mental health services that need them?
  - A I do not use "defund the police". I believe we need to rethink what we want to see in public safely. We need a strong effort to understand what we need and where we need it. We need to reevaluate the complete legal system
  - Q What is the best way to keep up to date on what's going on in Salem?
  - A Do not rely on one source. I encourage following the Speaker of the House and Senator Michael Dembrow, OLIS website and different media sites such as OPB, Oregonian, and Portland Tribune.
  - Q Do you feel the protests have been helpful and what outcomes have you been happy to see out of the? Should the city keep them going?

A - I think the protests have been very helpful in making it clear that these are issues we need to address and that there are lots of people who are interested in it. I think the struggle we have had is sorting out the people who are there as agents provocateurs, doing it for the adrenaline rush or who wish to discredit the movement itself. I think they will create a reset in how we deal with a number of issues, including housing and healthcare.

#### NP Joint Statement on Homelessness - Introduction by Mike Vial

General Overview - current policy of Housing First isn't doing enough to address the issues that we are going through now. On one hand, there are alot of people unsheltered and in need of services that they are not getting. On the other hand, neighbors and business owners are upset with the current state of affairs and are demanding something be done. Solution this group came up with is the establishment of sanctioned camps in every neighborhood. Neighborhoods would work with the Joint Office of Homeless Services establishing a sanctioned camp in their neighborhood. In return for this support the neighborhood would have a say in determining location of the camp and there will be additional enforcement on RV and street camping.
